3. <u>INTRODUCTION TO TOPIC</u>

- Supposed to be judicial prospective on inter-jurisdictional aspects of *Bankruptcy* and *Insolvency*

- Observations on flow to Ontario from Quebec and elsewhere
 - Trend unmistakeable
 - Teleglobe, Bell Canada International (not insolvency), Air Canada Ivaco and many others
 - Toronto is Delaware of Canada
 - Why?
 - Easy top-level answer: that's what the companies want based on advice given
 - Analysis of reasons for this (not in detail merely a few ideas):
 - Do not think that trend is based on self-serving advice given by professionals
 - Decisions are made in people's own enlightened selfinterest
 - clients understandably do what they think is best for them

- Quebec professionals involved they do what is best for the client
- Don't blame anyone in Ontario they are to be congratulated
 - Pogo comics: we've discovered who the enemy is; the enemy is us
- If we don't like the situation, we must find a way to fix it
 - Fix must be based upon better, more professional, more timely service not by criticizing or creating barriers
 - flow will not stop by administering an injection
 - Unless professionals and government, with the assistance of the judiciary, can work together to make us better (not to complain about others) we might as well buy a book of train, plane and bus tickets to Toronto
