

International Trade

Overview

International trade is in the spotlight once again. While free trade agreements generally discourage imposing tariffs on foreign goods, these agreements include an exception allowing countries to impose duties on "unfair" trade when products are dumped at low prices or subsidized by foreign governments.

The number of new unfair trade investigations has been increasing steadily in Canada since 2017. By the end of 2020, Canada had initiated a near-record number of new cases. Canada has also enacted new rules around customs, brokering, imports, exports and sanctions, which affect how Canadian and international companies can do business.
